Mark Rutherford is running for Indiana secretary of state, the office that oversees elections, business services, and securities. The Carmel attorney's legal practice includes concentrations in election law, and small business.

Rutherford is a lifelong Hoosier. Born Dec. 12, 1959 in New Albany, Indiana, he was raised in Clarksville, Columbus, and Carmel. In 1976, he obtained the rank of Eagle Scout. He graduated from Carmel High School in 1978. In 1982, he earned his Bachelor of Arts from Wabash College, then in 1986 was awarded his Juris Doctor degree from Valparaiso University School of Law.

Rutherford has been admitted to practice law in the State of Indiana; U.S. District Courts, Northern and Southern Districts of Indiana; and the U.S. Court of Appeals, Seventh Circuit. His practice focuses on business law and litigation; criminal law for business, their owners, and their families; election law and mediation.

He currently practices law for Thrasher Buschmann & Voelkel, P.C. in Indianapolis. He began as an attorney of counsel, then was invited to become a shareholder in January 2007. He previously practiced law with Laudig George Rutherford & Sipes in Indianapolis. As a small-business owner, he practiced at Mark W. Rutherford, Attorney at Law, also in Indianapolis.

Rutherford served as a public defender for Marion County Superior Criminal Court V and was a deputy prosecutor with the Marion County Prosecutor's Office. Both courts are in Indianapolis.

Gov. Mitch Daniels appointed Rutherford in 2007 to the Indiana Public Defenders Commission as a non-Republican nominee, and was re-appointed by governors Daniels and Eric Holcomb. The commission selected Rutherford as its chair in 2007, and he continues to lead the commission today.

Rutherford served as chair of the Libertarian Party of Indiana, and vice chair of the Libertarian Party National Committee.
